The Texas Watermelon Association reserves the right to ask for the resignation of the reigning Texas Watermelon Queen upon the recommendation from the Texas Watermelon Queen Coordinator and the Texas Watermelon Association Queen Committee. Texas Watermelon Queen contestants must be at least 18 years old (and have completed high school) and no more than 24 years of age by April 1st, 2026.

And, if winning the National Watermelon Queen title I will only represent the National Watermelon Association for a full year until the new queen is selected, and I will have no other activities which will interfere with my representation of the National Watermelon Association during my reign. I will be available for promotions the entire summer and for all other scheduled promotions. National Watermelon Queen contestants must be at least 19 years old and no more than 25 years of age by April 1, 2027.

TEXAS WATERMELON QUEEN AND TOUR GUIDELINES & REQUIREMENTS

THE TEXAS WATERMELON ASSOCIATION RESERVES THE RIGHT TO ASK FOR THE RESIGNATION OF THE REIGNING TEXAS WATERMELON QUEEN WITH THE RECOMMENDATION FROM THE TEXAS WATERMELON QUEEN COORDINATOR, THE TEXAS WATERMELON ASSOCIATION QUEEN COMMITTEE, AND THE TEXAS WATERMELON ASSOCIATION. ALL MONEYS, CROWN, AND BANNER WILL BE RETURNED TO THE ASSOCIATION IF ASKED TO RESIGN. THE TEXAS WATERMELON ASSOCIATION HAS SET FORTH THE FOLLOWING RULES TO BE FOLLOWED BY THE TEXAS WATERMELON QUEEN.

CONTESTANTS MUST SUBMIT 6 SIZE 5x7 black & white or COLORED PHOTOS WITH THIS FORM. HIGH RES PHOTOS CAN ALSO BE EMAILED TO BARBARA AND THE TX WATERMELONS GMAIL.

- 1) QUEEN MUST BE AT LEAST 18 AND NO MORE THAN 24 YEARS OF AGE BY APRIL 1, 2026.
- 2) CROWN AND BANNER ARE TO BE WORN AS REQUESTED.
- 3) DRESS CODE TO INCLUDE SHIRTS, TOPS, BLOUSES, DRESS SLACKS, DRESSES AND EVENING WEAR OF A CONSERVATIVE NATURE. If in doubt, consult with coordinator.
- 4) NO JEANS, SHORT SHORTS, OR MINI SKIRTS ARE TO BE WORN AT ANY APPEARANCE UNLESS APPROVED IN ADVANCE.
- 5) QUEEN MUST BE AVAILABLE BY TELEPHONE AT ALL TIMES DURING THE TOUR MONTHS AND RETURN TELEPHONE CALL TO COORDINATOR.
- 6) QUEEN UNABLE TO COMPLETE REIGN WILL RETURN ALL MONEYS, ETC TO THE ASSOCIATION.
- 7) QUEEN MUST COMPETE IN THE NATIONAL WATERMELON QUEEN CONTEST AND IF WINNING, COMPLETE REIGN BY NWA RULES.
- 8) IF THE QUEEN HAS AN UNAVOIDABLE REASON FOR NOT APPEARING FOR A PROMOTION, THE 1ST OR 2ND RUNNER UP MAY BE SUBSTITUTED TO FULFILL.
