The Texas Watermelon Association requirements for our Board of Directors according to our Bylaws:

The current Board of Directors count is 25 for 2024-2025.

The Board of Directors shall be made up of not less than seven (7) nor more than thirty-six members (36).

- A. The Board of Directors shall be elected by the members from among their numbers at the annual meeting of the membership, and their terms of office shall be for one year or until their successors have been elected and have qualified.
- B. No person shall be elected to the Board of Directors until he has been a member in good standing continuously for a period of two years.
- C. The retiring President shall automatically become the Chairman of the Board of Directors on his retirement from the Presidency and shall preside at all meetings of the Board of Directors; and in his absence or disqualification, the President, a Vice President or any member may preside in his stead.
- D. The President, Vice Presidents, Secretary and Treasurer shall by reason of their office be members of the Board of Directors.
- E. The Board of Directors shall have a general management of the affairs of the association but may delegate to committees of their number such authority as they may deem wise and expedient.
- F. If any member of the Board of Directors fails to attend the annual meeting of the Board for two consecutive years without due cause, his membership therein may be declared vacant by the remaining members thereof who shall elect his successor to serve until the next annual meeting of the membership.
- G. Vacancies which may occur in the Board of Directors shall be filled by the President's nomination and approval by the remainder of the Board of Directors, in which event the term of office shall expire at the next annual meeting.
